

DATA PROTECTION STATEMENT

I. PURPOSE:

AFC LIVE is committed to protecting the privacy and confidentiality of the personal data entrusted to it by its clients, employees, business partners, and other stakeholders.

We recognize the importance of safeguarding personal information and are committed to ensuring that all personal data is processed in accordance with applicable data protection laws, regulations, and regulatory requirements.

II. OUR COMMITMENT:

We process personal data lawfully, fairly, and transparently, ensuring that individuals are informed about how their information is collected, used, stored, disclosed, and retained.

Personal data is collected only for specified, explicit, and legitimate purposes and is not processed in a manner that is incompatible with those purposes.

The Company adheres to the fundamental principles of applicable data protection laws and internationally recognized privacy standards by ensuring that Personal Data is:

- processed lawfully, fairly and transparently;
 - collected only for specified and legitimate purposes;
 - adequate, relevant and limited to what is necessary for the intended purpose;
 - accurate and kept up to date;
 - retained only for as long as necessary to fulfil legal, regulatory and business requirements;
 - processed in a manner that respects the rights of data subjects;
 - protected against unauthorized or unlawful processing, accidental loss, destruction or damage through appropriate technical and organizational security measures; and
 - transferred across jurisdictions only where permitted by law and where an adequate level of protection is ensured.
- Personal Data We Collect

Depending on the nature of our relationship with you, we may collect personal information including identification details, contact information, financial information, employment information, customer due diligence (CDD) and Know Your Client (KYC) documentation, transaction information, and any other information required to comply with our legal and regulatory obligations.

Where required by law, we may also process special categories of personal data only where permitted under applicable data protection laws.

III. PURPOSES OF PROCESSING:

Personal data is processed for legitimate business and regulatory purposes, including but not limited to:

- customer onboarding and account administration;
- Know Your Client (KYC) and Customer Due Diligence (CDD) procedures;
- anti-money laundering and counter-terrorism financing compliance;
- execution and administration of financial services and transactions;
- compliance with legal, regulatory and reporting obligations;
- employee recruitment and human resource administration;
- risk management, fraud prevention and security monitoring;
- maintaining business records and internal administration; and
- responding to requests, enquiries and complaints.

We will only process personal data where we have an appropriate legal basis to do so, including consent where required.

IV. SECURITY OF PERSONAL DATA:

AFC LIVE maintains appropriate administrative, technical and physical safeguards designed to protect personal data against unauthorized access, disclosure, alteration, misuse, accidental loss or destruction.

Access to personal data is restricted to authorized personnel who require such information to perform their duties and who are subject to confidentiality obligations.

The Company continually reviews and enhances its security measures to maintain the integrity, confidentiality and availability of personal information.

V. DATA SUBJECT RIGHTS:

Subject to applicable data protection laws, individuals whose personal data we process may, subject to applicable legal limitations, exercise the following rights:

- request access to their personal data;
- request correction of inaccurate or incomplete personal data;
- request erasure of personal data where applicable;
- request restriction of processing;
- object to certain processing activities;
- withdraw consent where processing is based on consent; and
- lodge a complaint with the competent data protection authority or supervisory authority where they believe their rights have been infringed.

The Company will respond to requests in accordance with the requirements and timeframes prescribed under applicable law.

VI. ACCOUNTABILITY:

AFC LIVE has implemented appropriate governance arrangements to ensure compliance with applicable data protection laws and regulations.

These include maintaining records of processing activities, implementing appropriate policies and procedures, providing employee awareness and training, conducting risk assessments where necessary, and appointing a Data Protection Officer to oversee compliance with applicable data protection obligations.
